Many mutual funds offer different classes of shares. These are shares in the same fund. The values within a fund do not differ from one another, so that the performance is similar for each share class.

Share classes can differ, for example, in the use of income (distributing / accumulating), the amount of the front-end load and the management fee or the minimum investment amount. Slight deviations in terms of performance may arise from the fact that the ongoing fees are different. The share classes are also called tranches.

Each share class has its own securities identification number (WKN) and an international securities identification number (ISIN).

#### SHARE CLASS FOR RETAIL DISTRIBUTION

Share class that is used in sales with a possible front-end load that can be discounted up to 100% depending on the bank or distributor.
